

Our Minister's Letter



Dear Friends

As you may know, big changes are afoot in how the Church of Scotland is organised. The General Assembly of 2019 decided that the number of presbyteries in Scotland will be reduced from over 40 to about 12. Gordon Presbytery will join with the Presbyteries of Aberdeen and Shetland, Buchan, Kincardine and Deeside, Orkney and the eastern half of Moray. In preparation, Gordon Presbytery is formulating a new 'Presbytery Plan'.

The Church of Scotland has always been committed to providing 'the ordinances of religion' in every parish in the country, usually a local

church with a dedicated, professional minister. Changes in society (declining and ageing church membership, fewer candidates for ministry, and the retiral of many existing ministers) have made this harder to achieve.

Currently, the Presbytery of Gordon has 25 charges covering 28 congregations, there are 21 full time equivalent ministers of word and sacrament (FTEMWS) in post. In 2018 Gordon Presbytery was told to expect to have 14.9 FTEMWS by 2023. To cope with these changes, each congregation in the presbytery has been put into a parish grouping, based on a combination of geography and history of working together. We have been grouped with Inverurie West Church. Over the next 1-2 years, each parish grouping is expected to develop a covenant agreement detailing how they will work in partnership on the five marks of mission:

The mission of the Church is the mission of Christ:

- 1. To proclaim the Good News of the Kingdom.
- 2. To teach, baptise and nurture new believers.
- 3. To respond to human need by loving service.
- 4. To transform unjust structures of society, to challenge violence of every kind and pursue peace and reconciliation.
- 5. To strive to safeguard the integrity of creation and sustain and renew the life of the earth.

To meet the reduction in minister numbers, each parish grouping must agree procedures to follow if a vacancy should arise in the next five years. Our parish grouping will be entitled to just one FTEMWS should either Rhona or myself move on (I'm not planning to!). In addition, over the next 10 years, our parish grouping will be expected to reduce the number of buildings, from four (two churches and two halls) to three.

These are challenging times. At national level, work is ongoing to change church law and develop new tools to help churches work together in different ways. In Gordon, all congregations and groupings are facing difficult decisions; success depends on changing how ministers, Kirk sessions and congregations work together for the benefit of all.

If you have any thoughts or comments about these proposals, please contact any elder, or myself, before the Kirk session meeting on Wednesday 10 February. The draft Presbytery plan will be discussed at that meeting and representatives will be selected to join a small team with the West Church to begin working on our covenant agreement. Presbytery will next meet on 2 March to receive feedback and vote on the plan.


"Eyes on Jesus: Daily Devotions for Lent & Easter" (by Julie Riddle)

News from the combined Congregational Board/ Kirk Session Meeting held on Wednesday 13 January 2021 at 7.00 pm, via a Zoom Video Conference:

Key Points

- No volunteers have come forward for the Treasurer and Fabric Convener roles. Adverts have been placed on St. Andrew's, Presbytery of Gordon and Inverurie Residents Facebook pages. Contact for more information is the Church Administrator.
- Further research will be carried out on costs for a phone-in option for members to join in the Board, Session meetings as an alternative to videoconferencing. Any Board, Session members who would be interested in using this facility should contact the Church Administrator.
- Church buildings remain closed in accordance with prevailing Government and Church of Scotland guidelines with a consequent continued severe impact on lettings income and social events income.
- The Draft 2020 Annual Report and Accounts were approved for further processing.
- The 2021 Budget was approved. Overarching message is that 2021 will be financially very difficult due to the COVID restrictions uncertainties.
- Presbytery Citation on Presbytery Plan review Group was read out and will be read out again on Sunday 17 January 2021 online worship.
- Due to the restrictions (stay at home) we are unable to hand deliver the Saltire magazine. It will continue to be produced monthly and made available online through the website. As soon as hand delivery is permitted, hand delivery (including back issues) will recommence.
- Ordination of our four new Elders is not permitted under the current restrictions and is thus deferred. They will nonetheless be invited to join in the Board, Session meetings.
- We are proposing to have a Lent online discussion group. If you wish to join in please let the Church Administrator know.

The office remains closed. The Church Administrator (Linsey) is working from home and can be contacted by telephone (01467 628740) during the normal office hours - Monday to Friday from 09:30 to 11:30 am.

Categories

- Items that could be created and exhibited include knitting, crochet, tapestry, cross stitch, embroidery, felting, paintings, drawings, stick / crook making, wood turning, basket making, poetry, prose (maximum A3 format.)
- We kindly ask for no photography.
- If the item is designed to be hung e.g. the painting, drawing, embroidery or prose it should be presented in such a way to make this possible e.g. framed and or mounted.

Size

- We will try and accommodate all contributions but for the sake of space we would encourage art work to be no larger than A2 (approx. 420mm x 600mm).

Here is a piece of information which some of you may find interesting - I certainly did and not just because it involved my daughter in law, Barbara!

Barbara was born in Brussels and is Belgian by nationality. In 2006 she married our son Mark in London and they have 2 sons, Ben and Max, who always attend St Andrew's Church when they stay with Granny and Grandpa in Inverurie. Until recently, Belgium did not allow their citizens to hold 2 passports, but when this changed, Barbara decided to apply for a British passport - especially with Brexit coming into force. I naively thought the process would be a doddle. After all said and done, Barbara had been in the UK for 15 years, had gained a second degree from London University

and is a highly respected psychotherapist working with people who have difficult and challenging mental issues. As a result of being in full employment, she has paid her taxes for many years to the UK government.

How wrong I was!

First of all, Barbara had to apply and then sit a very stiff examination consisting of 24 random questions from an assortment of 470 pieces of information. She was delighted when she passed (pass rate is no less than 18) but then she had to take several documents (husband's passport, 5 years of paperwork to show tax returns, various qualifications, references etc) to a Government Office.

She is now waiting for final confirmation that she can apply for a British passport. And do not think this comes for free! The cost is at present heading towards £2,000.00!

Letter from David & Rebecca Morton

22 January 2021

Dear All,

It has been a while since we have communicated with you. Rebecca and I are still living on Lookout Mountain, here in Georgia USA, caring for my aunt who will be 90 in March this year, and is ventilator dependent at home. David is working part-time at a local community mental health clinic serving a very poor and disadvantaged population. He also teaches part -time at Covenant College here on Lookout Mountain, as an adjunct professor in the Community Development department. In the 2020 Fall semester he taught Global Health, and this semester will be teaching Emerging Diseases and Global Epidemics.

Speaking of Global Epidemics, the Covid-19 situation in Malawi had been manageable up until the end of December, when it exploded. Prior to Christmas the country was seeing an average of 0-3 cases per day. On 20 January there were 1,000 cases just on that day. Two cabinet ministers have died of Covid over the past 2 weeks. The country is overwhelmed, without adequate equipment, medications, or oxygen. The anti-viral treatments and the vaccines available here in the USA or UK, are not available at all in Malawi. Nkhoma is facing great difficulty in affording and obtaining what is available. Just yesterday at my request they sent a preliminary budget of the needs, totaling \$40,500:

- 1. \$11,900 6 month staffing cost
- 2. \$9,700 drugs for patient care
- 3. \$7,480 transport to Lilongwe for very critical patients
- 4. \$6,570 Oxygen
- 5. \$4,850 for covid testing

TOTAL - \$40,500

We are reaching out to multiple sources for assistance. But it is not just the funding, the staff are stressed and overwhelmed. Even when funds are available, sourcing the supplies and oxygen is difficult as the demand is outstripping the supply, especially with oxygen (ventilators are not an option as there are probably less than 20, if that, country wide, and none at Nkhoma). So please pray not only that funding will be available, but that the hospital will be able to source through local suppliers what is needed, especially the oxygen. Please especially pray for Dr Catherine Hodge who is the one overall in-charge of the Covid care at Nkhoma, Paul Mekani the principal nursing officer responsible for the nursing staffing needed, and all the doctors, clinicians and nurses who care for patients, that they will not fear, not be overwhelmed and will be able to remain faithful to their calling to "serve with love and care" as the hospital moto states.

christian allo Aid report surveys climate breakdown

A new report by Christian Aid, *Counting the cost 2020: a year of climate breakdown*, has identified 15 of the most destructive climate disasters of the year.

Ten of those events cost \$1.5 billion or more, with nine of them causing damage worth at least \$5 billion. Most of these estimates are based only on insured losses, meaning the true financial costs are likely to be higher.

Among them is Storm Ciara which struck the UK, Ireland and other European countries in February costing, \$2.7 billion and killing 14. The UK's Environment Agency issued 251 flood warnings.

While the report focuses on financial costs, which are usually higher in richer countries because they have more valuable property, some extreme weather events in 2020 were devastating in poorer countries, even though the price tag was lower. South Sudan, for example, experienced one of its worst floods on record, which killed 138 people and destroyed the year's crops.

Some of the disasters hit fast, like Cyclone Amphan, which struck the Bay of Bengal in May and caused losses valued at \$13 billion in just a few days. Other events unfolded over months, like floods in China and India, which had an estimated cost of \$32 billion and \$10 billion respectively. five of them associated with an unusually rainy monsoon. And in Africa, huge locust swarms ravaged crops and vegetation across several countries, causing damages estimated at \$8.5 billion. The outbreak has been linked to wet conditions brought about by unusual rains fuelled by climate change.

But the impact of extreme weather was felt all over the world. In Europe, two extra-tropical cyclones, Ciara and Alex, had a combined cost of almost \$6 billion. And the US suffered from both a recordbreaking hurricane season and a record-breaking fire season adding up to more than \$60 billion in damages.

Some less populated places also suffered the consequences of a warming world. In Siberia, a heat wave during the first half of the year set a record in the city of Verkhoyansk, with temperatures reaching 38°C. A few months later, on the other side of the world, heat and drought drove the fires in Bolivia, Argentina, Paraguay and Brazil. While there were no human casualties reported from these events, the destruction of these areas has a great impact on biodiversity and the planet's capacity to respond to a warmer world.

Christian Aid says that: "These extreme events highlight the need for urgent climate action. The Paris Agreement, which set the goal of keeping temperature rise 'well below' 2°C, and ideally 1.5° C, compared to pre-industrial levels, has just turned five years old. It is critical that countries commit to bold new targets ahead of the next climate conference, which will take place in Glasgow, in November 2021."

We are grateful, as always, for the support which we receive from your members, whether in terms of donations of food items or money, both equally important to our work. In Inverturie in 2019, we provided food for 622 households, comprising 859 adults and 645 children, a total of 1504 individuals fed. The comparative figures for 2020 show that we provided food for 825 households, made up of 1129 adults and 644

children, giving a total of 1773 people fed. This is an increase in usage of 17% over the previous year. Sadly, I don't think this trend is going to reverse any time soon. Although our focus is on feeding people, we are always grateful for donations of food for cats and dogs, because we often find that people who are in food poverty will feed a much loved pet first before they feed themselves.
